

## ONLINE PRIVACY POLICY AGREEMENT

January 01, 2024 Genesis Aero (Genesis Aero) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with Genesis Aero of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

We reserve the right to make changes to this Policy at any given time. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page. If at any point in time Genesis Aero decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Genesis Aero does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Genesis Aero may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. - as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Genesis Aero.

### **Notice to European Union Users**

Genesis Aero's operations are located primarily in the United States.
